Councillor Younger informed those present that the Aragon Housing Association, the District Council and the County Council are working on way to improve the parking situation in Gresham Way.

With regard to the A507, Cllr. Younger stated that Amey's are to publish speed limits prior to a crossing eventually.

It was thought that the Shefford Christmas lights display was probably the best in the county.

## **10. DISTRICT COUNCIL REPORT**

At the last meeting of the District Council's Executive it was agreed to roll out the food waste collection initiative to the whole area by October.
